Serial No.4, Reservation clause (ii) may be read as “The candidate who claims for reservation benefit will have to submit caste certificate/creamy layer certificate issued by the competent authority of his/her home district in the prescribed Performa of Govt. Of Jharkhand, issued not more than a year before. If the candidate does not have the recent certificate and have applied for the certificate he/she may submit the copy of acknowledgement submitted for the issue of certificate, along with the application. The candidates belonging to scheduled tribe/caste are required to submit only caste certificate issued by competent authority.”

Serial no 10, Documents to be submitted along with application by post clause (x) may be read as “CGPA/CPI/DGPA/OGPA conversion chart as mentioned on the reverse side of marksheets or charts issued by the university (as applicable). If the same is not submitted along with duly filled application form, the application of the candidate is liable to be rejected.

Serial no 11, General Information and instructions clause (iv) may be read as
Candidates may apply for more than one posts.
